The Exams. In most states, a new registered representative must - at a minimum - pass the Series 63 to satisfy state law registration requirements. The Series 63 (formally known as the Uniform Securities Agent State Law Examination) consists of 65 questions. Of this number, 60 count towards the candidate's score.

Series 63 - Uniform State Law Agent The Series 63 examination is required by most states for individuals who solicit orders for any type of security in that state. This license is required in addition to the registered representative license (e.g. Series 6 or Series 7 license).

Series 63 - Uniform State Law Agent - Pass Perfect
